## **GENERAL HOUSE RULES**

You are in a sober living program. Your success and continuance in this program is dependent upon your consistent good behavior and cooperation. Disruptive and/or discourteous behavior will not be tolerated. Any contact with illegal drugs and/or alcohol and/or violation of any of the following rules and guidelines can/will result in eviction. Your initials and signature indicates your understanding and agreement.

Consumption or possession of beverage alcohol in any form is prohibited.
Use or possession of illegal drugs in any form is strictly prohibited.
Use and/or possession of drugs and/or alcohol <u>will</u> result in immediate eviction. If eviction for drugs and/or alcohol the resident agrees to leave the premises immediately and not return for any reason whatsoever, without permission from house manager and/or Residential Living by Big Fish LLC.
Lying, cheating and stealing are strictly prohibited. If caught, you will be fined and/or evicted.
Residents are required to submit to a drug and alcohol screen/test at any time (24/7) it is requested. A refusal and/or failure to provide an adequate sample will be treated the same as a positive test result. Any attempt to cheat/circumvent test will result in fine/eviction.
Residents are required to maintain the home, common areas are to be shared cleaning duties. Chores are required to be completed daily.
Beds are required to be made upon waking. Personal areas are to be kept neat, clean and picked up at all times.
Residents are not permitted in any bedroom other than their own without permission from the resident residing in that room. They must also be accompanied by the permitting resident.
Kitchen appliances, countertops, utensils, dishes, pots and pans, etc., will be cleaned and returned to their respective place immediately after each use.
Refrigerator: Mark food/leftovers with name and date.
Washer/Dryer: clean dryer lint screen before and after every use and do not leave clothes unattended in washer/dryer.
Thermostat is to be adjusted by the house manager only.

Smoking inside the home is strictly prohibited.	
Turn off lights, TV, radios fans, etc. when not in use. Exterior doors are required to be lower when entering/exiting. No exceptions.	cked
Residents are required, at all times to wear appropriate clothing in common areas.	
Sleeping in common areas is prohibited.	
Disruptive/Discourteous behavior (yelling, screaming, fighting) will not be tolerated an will result in eviction.	d can/
Physical violence is strictly prohibited, it will result in immediate eviction.	
No one under 18 years allowed on property.	
Overnight guests are strictly prohibited.	
Three out of home overnights a week are allowed.	
Door code is never to be shared with anyone or given out.	
Curfew is 12:00 am. Failure to return to the house on time can/will result in eviction.	
House quiet time is 10:00 pm to 5:00 am. Any activity that disturbs another resident's ab sleep or rest is prohibited.	ility to
Evicted residents are required to leave the premises immediately and not return under a circumstances.	ny
Mandatory house meetings are held weekly at a date and time determined by the house manager or Residential Living by Big Fish LLC. An unexcused absence from any house meeting will result in a fine, or eviction.	ng can
